AS ONE OF THE LEADING EYE BANKS IN THE WORLD, IT PROVIDES RECOVERY AND DISTRIBUTION OF CORNEAL TISSUE FOR TRANSPLANT, PROCESSING OF CORNEAL TISSUE FOR SPECIFIC SURGERIES, EYE DONATION SERVICES/EDUCATION, AND DONOR FAMILY SUPPORT PROGRAMS. BEGINNING IN APRIL OF 2014, THE ACTIVITIES OF OCULAR SYSTEMS, LLC WERE ALSO INCLUDED AS A PART OF THIS PROGRAM. TOGETHER SIGHTLIFE AND OCULAR SYSTEMS ARE THE WORLD'S LARGEST PROVIDER OF CORNEAL TRANSPLANT TISSUE. THIS PROGRAM ALSO INCLUDES SALES OF DEVICES FOR CORNEAL DELIVERY SERVICES.

ESTABLISHED IN 2009, THIS INITIATIVE PROVIDES STRATEGIC, TECHNICAL AND FINANCIAL ASSISTANCE TO EYE BANK PARTNERS IN DEVELOPING COUNTRIES.
